- Global company
 - ✓ The startup company was founded within the past 7 years or less.
 - ✓ The service was released within the past 5 years or less. If the service has not yet been released, a demonstration should be ready by mid-December 2018.
- The service has never been presented at past FIBC events.
- The presentation must be conducted in English and include a demo.
- The event organizer may visit the startup office.
- The speaker must participate in a presentation practice held in January or February 2019 as well as a presentation rehearsal on 6th March 2019 (the day before the event) in Tokyo.
- The cost of accommodation, airline tickets, and other transportation expenses will not be covered by the event organizer.
- The presenter consents to the publication and use of all photographs/videos taken during the event on the FIBC official website, etc.
